	The DFS reported that the external auditors had requested that letters of support be issued by UWTSD for MCC, UWTSDI and CBM. These letters provided comfort that UWTSD would use its discretion on cash transactions in the period to ensure that the subsidiaries remained able to cover their liabilities for a period of 12 months. It was not expected that any subsidiary would require an injection of funds.

Officers believed that it would be prudent to delay detailed work on a new Plan for a year, which would also facilitate the joint development of an integrated plan
