



UWTSD BIODIVERSITY POLICY



1. Introduction

The Biodiversity Policy communicates University of Wales Trinity Saint David's commitment to a sustainable approach to biodiversity, as an integral element of its activities. It demonstrates our commitment to continual improvement in environmental practices, and will form the basis of the development of a series of campus-wide habitat management plans. These will then inform the development of an overarching University Biodiversity Action Plan.

2. Vision

Biodiversity Policy Vision: UWTSD is committed to conserving and enhancing biodiversity across its estate while engaging and inspiring its students, staff, and the wider community in biodiversity issues through involvement in projects and events.

3. Objectives:

In accordance with the Biodiversity Policy vision, the management of biodiversity at UWTSD will therefore be aligned with the following objectives:

- To conserve and enhance existing habitats and to create appropriate new habitats across the UWTSD campuses and Halls of Residence through the development and implementation of a UWTSD Biodiversity Action Plan (BAP).
- To undertake regular ecological surveys of all University campuses and Halls of Residence with an aim of maintaining up to date biodiversity records.
- iii. To consider ecological impacts and opportunities for ecological enhancement of any building refurbishments and any new building designs or construction activity.
- iv. To work with the grounds maintenance contractors and property managers to develop grounds management practices which conserve and enhance biodiversity.
- v. To educate students, staff and local residents on the value of biodiversity and raise awareness of the conservation work that is undertaken by the University.
- vi. To involve students, staff and the local community in biodiversity issues through volunteering, educational programmes and academic opportunities.
- vii. To maintain relations between appropriate and interested parties within the University.

- viii. To use biodiversity to promote healthy living and wellbeing through improved outdoor amenity areas.
- ix. To work in partnership with environmental groups and local authorities to share knowledge and resources.
- x. To seek funding and grants to facilitate the University's biodiversity aims.
- xi. To comply with all UK and EU legislation regarding biodiversity.
- xii. To communicate with stakeholders about our commitments and promote the benefits of biodiversity.

3. Scope

This policy is applicable all staff, students and other stakeholders at UWTSD.

4. Monitoring

UWTSD will establish a baseline and undertake regular ecological surveys during the year.
