21.35	Council CONSIDERED proposals for the bicentenary celebrations in 2022.	
Bicentenary celebrations	(JCO097).	
	Members noted that the celebrations would be focussed on the role of the University in shaping the nation and would commemorate the establishment of St David's College, Lampeter on 12 August 1822 through the laying of the foundation stone which marked the birthplace of higher education in Wales. The bicentenary would provide an opportunity to celebrate the history, successes and achievements of the University and its founding institutions over the past two centuries whilst also marking its current achievements and future aspirations. The Vice-Chancellor reported that the process for developing the programme of events had involved governors, staff, the Students' Union and alumni. He confirmed that staff were considering the development of publications on history, architecture and the special collections, and would also be maximising the opportunities for digital conferences. Members commended and ENDORSED the proposals, which celebrated not only the University's past but also its future. They noted the importance of linking with national events and also of celebrating in Wales the historic link with Oxford.
