	regard to arrangements for the third term. The Welsh Government had announced an additional £40m for student support for HE which would be distributed through HEFCW. The exact criteria was yet to be established. This was additional to the HEIR funding announced previously.	
	Structural Changes within the Management team The Vice-Chancellor reported that the Registrar would be leaving the University in March 2021. It was his intention to restructures the role of Registrar and Director of Strategic Planning and Business Analysis in order to enhance integration between financial and resource planning.	
	<u>USW Strategic Alliance</u> The Vice-Chancellor reported on continuing discussions regarding the development of the relationship.	
	Joint Venture The Vice-Chancellor provided an update on discussions with the Joint Venture partner. A full report would be presented to the next meeting of the Resources and Performance Committee.	
	Bicentenary Celebrations 2022 The Vice-Chancellor reported that a draft programme of events was currently being finalised with contingency arrangements if the pandemic continued. The programme would be presented for members' consideration in the next few months.	
	Confucius Institute The Vice-Chancellor referred to recent correspondence relating to possible political influence on the Confucius Institute and provided assurance in respect of the matters raised.	
	In discussion, members referred to the Covid-19 and the impact on mental health and enquired as to the support provided to staff and students. The Vice-Chancellor reported that the University had a well-established infrastructure to support students and was proactive in its engagement, and that the WG funding would allow the University to invest further in this area. The University had also been alert to its commitment to staff and detailed engagement had taken place with Unions in supporting staff. The DHR outlined the online resources available to staff and reported on the 24 hour online support service available together with Wellbeing Modules, with further modules and online service being developed jointly across Welsh universities.

21.8 UW and UWTSD Operational Integration plan	The Councils RECEIVED an overview of the planning undertaken for the UW and UWTSD integration together with an update on progress (JCO075).  The consolidated list identified those milestones which had been completed, were in progress, or were to be addressed closer to the point of full integration. There had been only limited changes to the consolidated list since its last presentation, reflecting the fact that the majority of outstanding actions now related to the final stages of integration.

Members AGREED that it was appropriate to archive the integration risk register as a separate document, noting that risk monitoring reports would continue to be presented the ARC through the Corporate risk register.
